### Subject of the Disclosure

### Background/Description of the Disclosure

The amendment on the primary purpose of the Articles of Incorporation of SMDC is as follows:

To engage in, operate, conduct, and maintain the business of purchasing, acquiring, owning, and holding real property, such as lands, buildings, factories, warehouses and other improvements, equipment, machineries, and other personal properties, for the purpose of leasing out the same.

The amendment on the secondary purpose (1) of the Articles of Incorporation of SMDC is as follows:

(1) To pay in cash, shares of its capital stock, debentures and other evidences of indebtedness, or other securities, as may be deemed expedient, for any business or property acquired by the Corporation
